# Legislative Black Caucus of Maryland Baltimore County Town Hall

On August 29th, members of the Legislative Black Caucus of Maryland gathered at West Towson Elementary School to deliver the third in a series of Town Halls throughout the State-discussing the Caucus priorities for the 2023 Legislative Session: Cannabis Legalization, Education, Wealth & Black Businesses, Health, and Housing and looking ahead to 2024.

Superintendent Dr. Myriam Rogers (Yarbrough) and Caucus Chair Jheanelle Wilkins provided opening remarks. Delegates Cheryl Pasteur and Aletheia R. McCaskill delivered a compelling exposition of the founding of



Antebellum Period free African-American communities like 43rd's East Towson, Turner Station, and Winters Lane in Baltimore County. Each caucus member presented wins in one of the priority policy areas. Senator Washington covered, among other things, the Maryland Educator Shortage Act (SB893), the Student Loan Debt Relief Tax Credit (HB680), and the need to ensure equity in our funding and policy decisions. Each member participated, including fellow EEE Committee member Senator Ben Brooks and Baltimore County Senate Delegation Chair, Senator Charles Sydnor.

### Maryland Higher Education Commission: Degree Program Review

In Maryland, degree reviews are driven by an objection process, and the most common complaint is that a new program would duplicate an existing one at another institution. On June 30th, the EEE Committee received a

letter from Morgan State University President Dr. David Wilson, requesting the Committee to weigh in on the Maryland Higher Education Commission (MHEC)'s decision to allow Towson University to implement a graduate program the University determined was substantially duplicative to an existing degree program it offers. Interestingly, these institutions are located in the 43rd District, just 4.6 miles apart. After much discussion, including a review by the Attorney General, Towson ultimately withdrew its program application.

**Background:** This past legislative session, the MGA passed HB200 to create a workgroup of stakeholders to study and develop measurable criteria to determine when a proposed new program is considered duplicative and already offered by one of Maryland's Historically Black Colleges and Universities (HBCUs). In July, Rai and Commission Chair Catherine "Cassie" Motz sent a memo suggesting that colleges and universities in the state pause their pursuit of new degree programs if another institution objects — at least until the workgroup makes recommendations on potential changes to state policy. The workgroup held its first meeting in August and is due to submit a report by December 1st.

# Maryland Supreme Court LGBTQIA+ Decision

The Maryland Supreme Court ruled on August 14th that state laws, such as the Equal Pay for Equal Work Act and the Fair Employment Act that usually grant job protections to workers on the basis of sex, do not extend to workers based on their sexual orientation. The ruling came from a case of a Catholic Relief Services employee suing for the right for his health insurance to extend to his husband, as such job benefits extend in straight marriages under the organization's policies. The Court ruled that while Maryland laws specify equal gender protections, there is no similar protection for LGBTQIA+ members of the Maryland Workforce.

Last month, the Maryland Legislative LGBTQ+ Caucus released a statement expressing profound concern: "The strides taken by the Maryland General Assembly in recent decades lay bare the collective resolve to dismantle and eliminate the deep-seated structures of discrimination. The Maryland LGBTQ+ Caucus is evaluating the ruling and will support legislative remedies that bridge the gaps caused by this ruling in our 2024 session."

### **Update: Maryland Public Service Commission Orders BGE to Allow Customers Options in Gas Regulator Location**

This Tuesday, The Maryland Public Service Commission ruled that Baltimore Gas and Electric customers can decide whether to have high-pressure gas regulators installed at their homes, and a judge extended the existing restraining order. Additionally, the Commission approved an agreement among Baltimore Gas and Electric Company, a group of affected customers, the Maryland Office of People's Counsel (OPC), and the Commission's Technical Staff that directs BGE to work with these parties to develop a written notice to be delivered to customers at least 14 days in advance of an installation, informing them a gas regulator will be installed and giving them the choice of exterior or interior installation.

**Background**: BGE adopted the default practice of external installation beginning in 2021, and complaints since then have related to the aesthetics and safety of external gas service regulators.

### Invasive Spotted Lanternflies Set to Swarm in September

The quarter-sized insects you may have seen throughout the Baltimore region this summer are set to enter a new stage-breeding season. Feeding on the sap of another invasive species, the Tree-of-Heaven, Spotted Lanternflies pose destructive risks to beneficial species and our local ecology.

### **MD Student Loan Debt Tax Credit** Deadline - 9/15

The Maryland Higher Education Commission provides all Maryland residents with a Student Loan Debt Relief Tax Credit program. A total of \$18 million in tax credits is available to Maryland residents filing their 2023 tax returns.

To be eligible, you must claim Maryland residency for the 2023 tax year, file 2023 Maryland state income taxes, have initially incurred at least \$20,000 in undergraduate and/or graduate student loan debt, and have at least \$5,000 in outstanding student loan debt at the time of applying for the tax credit.

### Water Bill Debt Relief

75,811 Baltimore City and County residents who accrued water bill debt during the COVID-19 pandemic will receive credits on their upcoming water bills. These credits are funded by a \$15.87 million grant under the American Rescue Plan Act. DPW is one of 19 water systems throughout the state that applied for and were awarded funding from the Maryland Water Assistance Relief Program.

Eligible customers will receive a credit for outstanding water bill debt accrued during the pandemic between Jan. 27, 2022 - Sept. 30, 2023. The grant distribution has been prioritized for City and County customers currently participating in financial water assistance programs.

\*\*DPW will notify the eligible City and County residents who will receive the debt relief credit.


